- I understand that approval of my application will result in the issuance of a license, not a lease, and that I will have no tenancy rights to any specific vendor space.
- I understand that rent is due monthly in advance, and that failure to pay rent when due may result in removal from the Dockyard Entrepreneur Program and termination of my license.
- I understand that the vendor license provides access only to an assigned 10 ft x 10 ft vendor space, and that tents, kiosks, or other structures are not provided by BLMC.
