*The governing terms & conditions of the
Transportation Access Pass for the Port of Dockyard*

2026 TERMS & CONDITIONS

Purpose

These Terms and Conditions inform you of the requirements and consequences associated with the use of the Port of Dockyard Transportation Access Pass. They specifically outline the obligations and rights of the Bermuda Land Management Corporation (hereinafter referred to as “BLMC” or “Port Authority”).

Agreement to Terms

These Terms (the “Terms”) govern your application organized by BLMC. By registering for the Port of Dockyard Transportation Access Pass, you agree to these Terms, which form a binding legal contract between BLMC and the registered applicant. If you are registering on behalf of another individual, it is your responsibility to ensure the applicant is aware of and accepts these Terms. By completing the registration for another individual, you warrant that you have informed the applicant of these Terms and that they have accepted them.

APPLICATION TERMS

1. The applicant must be at least 18 years of age.
2. The applicant will receive no remuneration or expense allowance for participation.
3. Access to the Port of Dockyard will only be granted after the information provided in the application is validated by an official photo ID, valid vehicle registration, etc
4. BLMC reserves the right to withdraw authorized access to the Port of Dockyard at any time.
5. BLMC reserves the right to enforce and regulate authorized access, including the duration of access.
6. BLMC does not guarantee authorized access to the applicant.
7. The application is free of charge for the applicant.
8. The application is a voluntary opportunity and should not be interpreted as a job offer from BLMC.
9. Approval of the application is solely at the discretion of BLMC.
10. The applicant agrees to be solely responsible for their vehicle(s) during their authorized access to the Port of Dockyard.
11. The applicant may opt out of their pre-authorized access at any time.

APPLICATION PROCESS

All applicants must complete all required fields on the application form and provide any necessary documentation. Approval is at the discretion of the Port Authority.

Applications are accepted year-round, but to ensure timely processing for the upcoming season, submissions should be received by submission deadline.

Obligations & Rights of Port Authority

The following outlines the rights and obligations of the Port Authority concerning the Port of Dockyard Transportation Access Pass.

1. The Port Authority is responsible for enforcing Inner Curb Access.
2. The Port Authority is not liable for any damage caused by the applicant’s involvement or negligent conduct of the applicant or any other individual.
3. The Port Authority reserves the right to refuse authorized access to the applicant without reason and/or to cancel it at any time after granting access.
4. The Port Authority is not responsible for the loss or damage of any property belonging to the applicant while at the port.
5. The Port Authority accepts no responsibility for any injury or disappointment incurred by any applicant as a result of entering or having access to the Port of Dockyard General Transportation Area (GTA), including loss of income, profits, or any other consequential damage.
6. The Port Authority staff reserve the right to remove individuals who do not cooperate and/or pose a threat.

Conditions of the Access Pass

Applicants and/or drivers must adhere to the BLMC Code of Conduct in addition to the following regulations of the Port of Dockyard and the General Transportation Area within the Port Facilities:

1. Overnight parking of any vehicle, specifically public service vehicles, is prohibited within Dockyard. Public service vehicles may not park overnight solely to gain access to the Port of Dockyard the following morning.
2. Speeding is prohibited. All vehicles must adhere to roadway signage, as the Port of Dockyard has a high level of pedestrian and vehicular traffic.
3. All drivers must comply with parking, waiting, and delivery stand signage within the Port of Dockyard.
4. Port Authority staff and traffic coordinators have the right to ask any drivers who do not cooperate or adhere to the terms and conditions outlined here to leave the secured port area.
5. Both minibuses and taxis are allowed to transport passengers via the Shuttle Line; however, only the shuttle rate shall apply when servicing passengers from the shuttle stand.
6. All tour operators must possess one of the following local certifications: Blue Flag and/or Anchor BDA Certified.
7. All public service vehicle drivers must display a photo ID with their name visible to any passengers.
8. All drivers must comply with the dress code set out by the BLMC Code of Conduct and the Traffic Control Department.
9. Each issued Access Pass will be valid from April 1st to March 31st each year.



Access Pass Usage

The port access pass is to be used solely by the person or entity to whom it has been issued. Unauthorized use is prohibited and may result in revocation of access.

Pass Validity

The pass remains valid for a seasonal period within one calendar year; after that, renewal is required. Expired passes will be considered invalid and access to the Port of Dockyard GTA will be denied.

The application period occurs annually from mid-January to early March.

Fees

Any fees associated with the access pass must be paid in full upon application. Failure to pay may result in the revocation of access. Currently, there are no fees.

Security Compliance

Pass holders must comply with all security regulations and procedures set forth by the Port Authority, including those established by Port Authority representatives such as, Traffic Coordinators (TCs), Security at the Port Gate, and Police Officers. This includes adhering to screening procedures and identification checks.

Liability

The Port Authority is not liable for any loss, damage, or injury resulting from the use of the Transportation Access Pass.

Revocation of Pass

The Port Authority reserves the right to revoke the Transportation Access Pass at any time for non-compliance with these terms or for any other reason deemed necessary.

Amendments

The Port Authority/Bermuda Land Management Corporation reserves the right to amend sections within these terms and conditions at any time. Notification of changes will be posted to the BLMC website at blmc.bm/access-pass.

We implement reasonable security measures to protect your personal information from unauthorized access, use, or disclosure. However, no method of transmission over the internet or electronic storage is completely secure.

SHARING OF INFORMATION

We do not sell, trade, or otherwise transfer your personal information to outside parties unless we provide advance notice. This does not include trusted third parties who assist us in operating our application or conducting our business, as long as those parties agree to keep this information confidential.

YOUR RIGHTS

You have the right to access, correct, or delete your personal information at any time. You may also have the right to restrict or object to processing in certain circumstances.

CHANGES TO THIS PRIVACY POLICY

We may update this privacy policy from time to time and will notify you of any changes.
